In continuation of the letter under reference and subsequent discussions, the details of NMEICT project are herewith forwarded with the following request:

- a) To advise the respective university authorities to take 1 GB connectivity to the nearest NKN node. Each university needs to pay one time payment of Rs.45 lakhs+10.3% Svc.Tax towards 1 GB connectivity for 10 years period. List of Universities is enclosed at Annexure-I.
- b) To advise all the universities (total 10 nos.) to cause necessary action to take 20 VPNoBB connections in each college (total 2159 colleges) under their jurisdiction. Each college has to pay Rs.1125 +10.3% Svc.tax per VPNoBB connection per annum. List of Colleges University wise is enclosed in Annexure-II.
- c) To convene a meeting with all concerned for explaining the importance of NMEICT Project, and ensure speedy implementation.


**Subject: Extension of NKN Connectivity to Universities under
