#### WHEREAS

CallHealth provides these services using a proprietary eHealth Platform, trained Medical Health Officers and by leveraging the ecosystem of healthcare providers such as Hospitals, Diagnostic Centers, Physician Consultants, Physiotherapists and others.

Subject to clause 8, upon expiry of the said Term, the Agreement shall get extended for a further period of time as agreed in writing upon such terms and conditions mutually agreed upon thereon.

#### 2. Obligations of the Educational Society

- 2.2 Provide student, staff and their family information to enable CallHealth to communicate, register and promote its services
- 2.3 Facilitate the delivery of services by CallHealth to students, parents and faculty. This includes fulfilling its obligations to students, parents and faculty.
- 2.4 Provide space and facilities such as electricity, internet connectivity, cleaning etcin order for CallHealth to promote and deliver its services
- 2.5 Enable CallHealth's branding in the facilities, including health lounge/ nursery
- 2.6 Inform CallHealth at the time of Personal Accidental Insurance renewal and provide the opportunity to CallHealth to become the health insurance provider
- 2.7 Abide by all the applicable laws, code of conduct or rules in discharge of its obligations under this Agreement.
- 2.8 Provide necessary consent to CallHealth to enable CallHealth to provide its services

#### 3. Obligations of CallHealth

  - Implementing Branding and Marketing Initiatives

(a) Either Party may terminate this Agreement at any time -

by giving 30 days of written notice of such termination to the other Party.

In the event of this Agreement being terminated, the Parties will endevour to complete all ongoing activities and facilitate easy transition to ensure minimal disruption.

#### 9. <u>Dispute Resolution</u>, Jurisdiction & Governing Law

The Parties agree that any dispute with regard to the interpretation of any terms of this Agreement, or with regard to any rights or liabilities of the parties arising out of this Agreement, or in any way connected with this Agreement, shall be referred to an arbitration tribunal, wherein each Party shall nominate one arbitrator and the two arbitrators shall appoint the third arbitrator. The three arbitrators shall constitute the arbitral tribunal. The arbitration proceedings shall be held at Hyderabad in accordance with the provisions of Indian Arbitration and Conciliation Act 1996 and any amendments thereof from time to time and the rules framed there under. This Agreement shall be governed by and construed and interpreted in accordance with the Laws of India. The seat and venue of arbitration shall be at Hyderabad, India. 
