

Eradication Of Child Labour



Ms. Snehitha said that, Vignan has a coherent and an effective anti-ragging policy in place which is based on the "UGC Regulation on Curbing the Menace of Ragging in Higher Educational Institutions. She addressed the Ragging constitutes one or more of the following acts:

- Any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness any student;
- Indulging in rowdy or undisciplined activities by any student or students which causes or
 is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or
 apprehension thereof in any other student;
- asking any student to do any act which such student will not in the ordinary course do and
 which has the effect of causing or generating a sense of shame, or torment or
 embarrassment so as to adversely affect the physique or psyche of such a student;
- any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any student;
- exploiting the services of a student for completing the academic tasks assigned to an individual or a group of students;
- any act of financial extortion or forceful expenditure burden put on a student by other students;
- any act of physical abuse including all variants of it: sexual abuse, stripping, forcing
 obscene and lewd acts, gestures, causing bodily harm or any other danger to health or





An Awareness program on Mental Health & Physical Health



Vimala expressed her view about mental health and physical health, but it is necessary to look for both of them together. Generally, mental health can be defined as how people feel, think and act when faced with life" s problems. In addition, a mental disease causes feelings of unhappiness, loss of hope, sleeping problems, changes in eating habits, loss of interest in natural activities, and pains which have no physical description. Occasionally, mental and physical illnesses appear similarity in many of symptoms, such as a decrease in food cravings and energy levels. Therefore, this essay aims to argue specific situations could have an effect on both mental and physical health. Poor physical health can lead to an increased risk of developing mental health problems. Similarly, poor mental health can negatively impact on physical health, leading to an increased risk of some conditions.



An awareness program against Discrimination towards others, Based on a protected class

Vignan's Foundation for Science, Technology & Research - Deemed to be University (VFSTR), has organized an awareness program "against discrimination towards others, Based on a protected class" by Sri. Mannava Subbarao - Andhra Pradesh NGO" s President. Sri. Subbarao garu has spoken about Discrimination towards others, based on a protected class is defined as unreasonable, unwelcome conduct, based on an individual" s gender, race, color, age, religion, national or ethnic origin, gender identity or expression, medical condition, veteran status, disability, or any other legally protected classification, that objectively and subjectively harms the person by severely, persistently, and/or pervasively denies the person equal access to educational opportunities, residence and community life, or terms and conditions of employment. This type of discrimination can occur in any form and can be directed at individuals or groups. Depending on the severity of the circumstances, infractions may be resolved through a variety of appropriate methods, ranging from informal, remedial steps, including training, counseling, or mediation to disciplinary action, up to and including suspension or expulsion. In all cases, the institute encourages individuals to seek support and assistance as soon as possible. Before any behavior can be considered for the student conduct process, it must be clear that no substantial free expression interests are threatened by bringing a formal charge of discrimination. If a person has been subject to discrimination including harassment on the basis of a protected classification, as described above, the student should consult with the director of equal opportunity and engagement for guidance. The program successfully conducted on 28th August, 2017.

"Adverse effects - Consumption of intoxicating drinks and drugs" *by* senior IPS officer Mr. M. Malakondaiah as the Director-General of Police (DGP), Head of Police Force (HoPF). Mr.

M. Malakondaiah said that drug and alcohol abuse can be devastating to a person's health and academic performance. To be more specific, getting intoxicated can have a negative impact on cognitive functions (concentration, memory, attention) for 48 hours. The recovery from smoking pot is more complex, and is described below in more detail, along with a more detailed discussion of the impact of alcohol. While by no means should this list be considered exhaustive, the following are some ways in which commonly used substances can be particular problems for students. While several problems can accompany substance use and abuse, this list focuses on those drugs that impact two domains that are clearly barriers to academic success-anxiety and cognitive functioning.
