Complaint-1:

A student of I. B.Tech, Food Technology Ms. Surya Tejaswi reported to the ICC-GSCASH, that a faculty member of IT department, Mr. Naresh was harassing her, by showing undue interest in her. He would often ask her to come to his cabin and attempt to be intimate with her by asking personal questions. Frightened by the advances being made by the faculty member, the girl stopped coming to the university. The girl's parents brought it to the attention of the Dean in the university and the case was taken up by the ICC. The case was successfully resolved with the faculty member being asked to resign and leave.

Complaint-2:

A non teaching staff member, Mrs. K. Sivakumari, the cleaning supervisor cum gardener, reported to the Chairperson of ICC-GSCASH that one of the Auditor's, Mr. K. Poleswara Rao who used to come for weekly audits to the unit, was frequently pestering her to go out with him for lunch and meet him personally outside the institution's working hours. She produced evidence of recorded telephone conversations, and a letter along with a complaint letter. Through multiple sittings of the panel, which involved enquiry of several people, the case was successfully resolved when the Auditing Firm agreed to fire the accused and made him render a letter of apology to the complainant.

No. of Workshops and awareness programmes on Gender Sensitization held during 1st April, 2015 to 31st March 2016:

The Internal Complaints Committee (ICC), GSCASH, VFSTR University periodically organizes programmes on Women Empowerment and Gender Sensitization. The Chairperson as well as the faculty members of ICC, GSCASH, VFSTR University has undergone the Capacity Building Workshops for women faculty members on Gender Sensitivity sponsored by UGC. The programmes organized for the concluded academic year, in the above mentioned period are as follows:

- As a part of the 10-day Bridge Course, during 18th to 27th June 2015, prior to the commencement of I B.Tech course, external trainers, Seventh Sense Training Solutions, Bengaluru trained students, both girls and boys, on overall Personality Development, and expected gender appropriate behavior in a co-education system.
- 2. Sensitisation of the I B.Tech women students: After the commencement of the first year course work, on 25th June, 2015, a sensitisation programme for girl students by key functionaries of the university like Dean, Student Affairs and Dean, Engineering & Management, with senior faculty counselors of the University Women Empowerment Cell organized an awareness programme to educate students on aspects of dressing, sensible and safe usage of electronic gadgets, social media and behavioural aspects with opposite gender, health issues etc. 612 women students were benefitted from this programme.
- 3. Health Camp: On the eve of Gandhi Jayanthi, a Health Camp was conducted in collaboration with "Helpline Hospitals" on 1st October, 2015 in the hostel premises of VFSTR University. 2 doctors and 3 supporting staff were involved in this camp. A preliminary checkup was done. It was observed that many students were suffering with Anaemia. Based on the advise of the doctors, lot of changes were made in the hostel menu to supplement the nutrients for anaemia.
- 4. A symposium on the 7th of March 2016, on the eve of the International Women's Day was conducted was organized in which 56 women participants from 12 nearby institutions participated. On 8th March, a panel discussion on "Challenges for women working in the fields of Education, Health and Industry "was conducted with four invited women experts from diverse domains. The panel discussion covered issues like Violence against Women, Employment Opportunities in Teaching & Research, Women in Entrepreneurship, Women in Agriculture Sector, Laws governing Gender discrimination, NGOs for Custodial Justice etc.
